This is the complete agreement between the parties hereto, with the terms and conditions defined herein being the sole governing terms and conditions. Terms and conditions on any Bill of Lading or other shipment paperwork which contradict the terms hereof are considered null and void.

***Declared Value:** (Full terms in items 560 and 565 of Passport Transport Tariff 101): Passport Auto Transport liability is limited to a \$100,000.00 released valuation per vehicle unless a higher value, not exceeding \$150,000.00, is declared at time of original shipment tender (service order placement) and is verified as such on the bill of lading and/or electronic media and a fee of thirty cents (\$.30) per \$100.00 of value declared over \$100,000.00 is paid. transportation of any commodity, Passport Auto Transport will only be liable for the cost of repair, cost to replace, released value or declared value, whichever is less.
